#### **Budmouth Windsurf Club**

The opportunity has arisen to restart the Budmouth Windsurf Club with The OTC Centre in Portland. During these sessions, students will be taught the basics of the sport and be given time to practise. If some students are already experienced, they will still be able to receive some coaching and guidance. Places are limited on this trip due to instructor ratio (12 places max). Therefore, if you are interested please collect a letter from me, in the PE office as soon as possible.

Your child's place will be secured once payment (please pay via ParentMail) and the completed consent form are received by Mrs Tewkesbury in the Finance Department.

Should you wish your child to attend but are concerned about the cost, please phone or email me to enquire about the possibility of receiving financial assistance. We are keen to give all students equal access to sporting opportunities like this.

If there is no wind, there is the option to go SUPing (Stand up paddleboarding). If the weather conditions are not appropriate for our students, we will rearrange the session for another week. It is vital we give the students positive experiences! Wetsuits, helmets and buoyancy aids are provided by the centre. I recommend students wear old trainers. If students enjoy the sessions, wetsuit boots are a really good purchase to protect the toes and keep feet warm!

Students will be returned back to Budmouth Academy. I will advise students to contact home on their return to school to give an ETA. This is due to the fact that timings can vary due to session times, weather, traffic which are all variables that are difficult to predict. Once students are back on site, responsibility is handed back over to parents/carers.
